



## Jim Baugh

September 23, 1967 - July 2, 2022

Jim Baugh, 54, of Oskaloosa, passed away Saturday, July 2, 2022, at Unity Point Iowa Methodist Medical Center in Des Moines.

Jimmy Edward Baugh, son of Jimmie Otis and Elaine Kay (Steinfeldt) Baugh, was born September 23, 1967, in Odessa, Texas. When Jim was a child, his family moved to Eldora, Iowa, where he received his education. After finishing school, he went to work operating heavy equipment, most recently in the Marshalltown/Newton area. He moved to Oskaloosa in 2017. Jim was a Ford man; he and his sons and grandsons enjoyed racing stock cars and derby cars on many weekends and he enjoyed camping with his grandchildren. Jim collected guns, and he enjoyed target practice. He also enjoyed woodworking and watching U-Tube videos. He attended the First Assembly of God Church.
